Calamity Council - Stated Wrong Ward for Election

Mistake NOT noticed by Staff or Cllrs No Apology from any Cllr Reluctance to Extend Deadline was

Following the resignation of another Town Councillor (David Frame), Wetherby Town Council stated on their Facebook page and posted on social media (with an audience of 10s of 1000s) that 10 residents must take action to get an election in North Wetherby. The vacancy is actually in West Wetherby.

Residents of that ward had only 2 days to contact Leeds City Council instead of 14. A resident discovered this serious error, not a Councillor or Council staff. As a result of it, the Free Press spread the wrong information to 1000s more on social media. We naturally asked for an extension to the deadline, which was initially ignored.

We asked long-standing Councillor Norma Harrington who is also Chair of the Staffing Ctte for her view on misleading 1000s of residents and any actions she will take to get an extension. She responded with an email containing no such actions, no opinion, no apology and no explanation of why she or her 13 colleagues did not notice such a large error.

We also sent the same email to spokesperson for the Council, Mayor Cllr Connor Mulhall. He is also Chair of the Comms Ctte and this was clearly a serious communications error. He did not respond at all.

The Town Clerk called the error a 'typo' and expressed no regret in the first response she sent us. On social media, she said sorry 'for the confusion'.

Town Clerk Response

I was made aware of this late last night, but I have to advise that the original notice displayed on our website did indeed have the correct information as did the notices on the notice boards.

Facebook is an additional tool to the communication regime and is not considered as the legal entity, it is a conduit to advertise daily updates. The error was a typo and was not intentional by anyone at WTC.

I have asked electoral services at LCC if they require WTC to extend the notice of vacancy."

In response the Editor said he believed the website was incorrect as well because of an email he sent to a Councillor BEFORE the error was noticed by anybody. It said "From the Website" and continued to quote the Council's statement with the incorrect ward in it. He also said "Common sense and





to register their interest in an election. Why did you / the Council not push for one?"

In response to this, the Town Clerk stated again that it was always the correct ward on the website. She added at the end "I wiill (sic) however ask the council if they wish to extend the notice period."

Cllr Harrington Response

"Good evening, The Clerk has enquired

into this issue and has posted about the error on social media and has been in touch with the electoral services department at LCC.

I understand the correct information was posted on Leeds City Council's page and they are considering the legislation to see if they need to extend the deadline.

The Clerk will post any updates on social media. Thank you"

In response the Editor noted that her email contained no actions from her about the extension, no opinion, no apology and no explanation of why she or her 13 colleagues did not notice such a large error. He asked her to confirm that the incorrect ward was publicised in a previous election and the details of it. And to confirm that this is not a deliberate strategy so that the Council can choose their own candidate.

Cllr Harrington responded "Good evening Mr Kirby

The Council have followed all procedures appropriately and have had confirmation of same from LCC. The clerk has responded by posting on social media. You will note that we had an election in recent years and two co- options which led to a mix of councillors representing the people of Wetherby. It is unfortunate that one post had a typing error in it but this has not caused any delay to the requisite number of electors writing to LCC. Their legal department was satisfied that the correct details were displayed adequately. Steps will be put in place to ensure that any posts put out are accurate in future."

My response stated that she had not addressed any of the issues I raised. I told her that she had repeated what I know already and I find it very disrespectful and frustrating. I added: "It is extremely interesting that you refuse to

a) provide any details of the previous error (which you do not deny occurred)

b) confirm that these 'errors' are not a deliberate strategy by the Council". In her next email Cllr Harrington denied that such a strategy exists. It did not mention the previous similar error we asked about.

We also reminded Cllr Harrington that we have the luxury of having a Communications Officer so Council Tax payers should expect a very high standard of communication at all times.
